ELIGIBILITY

Entries will be accepted from any genuine contractor carrying out painting and decorating contracts, either on new works, refurbishments or redecoration in England, Ireland, Wales and Scotland. Businesses may submit as many contracts as desired; however each must be submitted on a separate entry form. Contracts must have been completed using either Johnstone's, Leyland or PPG branded materials in the period 1st January 2018 to 31st December 2018.

On submitting an entry the company confirms that it has been the main contractor and that the project has been managed and completed by them. Due to this being a decorative award, sub-contractors who have been significantly involved in the decorative application of coatings should always be recognised.

CLOSING DATE

All entries must be received by Friday 14th December 2018, entries after this date may not be considered.

PHOTOGRAPHS

Each application must be supported by a minimum of 4 different colour images of the completed contract. Please ensure every submitted image is labelled with the name of the entrant. Images can be supplied on CD or USB stick if preferred.

If photography is not supplied with entry form, the entry cannot be accepted. Please provide before and after photos where possible.

ASSESSMENT CRITERIA

We are looking for contracts that demonstrate the highest quality of workmanship, craftsmanship and expertise.

The complexity of the contract, management of the project and achieving consistent quality will all be considered.

Please provide full details of the works being entered, using extra sheets of paper if required. These should be accompanied wherever possible by detailed before and after colour images.

Each application will be thoroughly assessed by our National Judging Panel. Shortlisted works will then be subject to comprehensive site visits from our Technical Judges.
